




# Fare schedule – Paratransit

Effective July 1, 2024

- The All Modes ABC ticket is accepted for all trips presented in this fare schedule.
- Children aged 11 and under can travel for free on public transit at all times, while accompanied by a person aged 14 or older who is supervising them. The accompanying person must have a valid fare and may not accompany more than five children aged 6 to 11.

## IMPORTANT

You must show your Transport adapté card every time you use our paratransit service. Transit fares are not sold on Transport adapté véhicules. Exact change is required for cash payment on vehicles.

The OPUS card is required for the monthly ticket only and not for the 1-trip pass or the virtual pass.

Conditions regarding the possession and use of transit fares are prescribed by the ARTM under the regulatory power of section 106 of the Act respecting the Autorité régionale de transport métropolitain (CQLR c A-33.3).
